Proposals; We would like to request TN government;

- 1. to speed up the installation of new water sources from <u>STP</u> <u>in Koyambedu (90MLD)</u> and its pipeline to SIPCOT.
- 2. to consider pipeline connection inside SIPCOT to the individual manufacturers which need water supply by pipeline.
- to consider another new water sources to each Industrial Park.
- 4. to improve the quality of the water from existing pipeline.

- Agenda 2. Issue in the Vallam Vadagal industrial park Land Price
 - The issue of Land price increase in the Vallam Vadagal Industrial Park has been discussed between JCCIC and SIPCOT along with Government of Tamil Nadu for the past 2 years.
 - At the JWC on 16th-July 2018, SIPCOT MD informed the revised price with the reason for increase the cost in land.
 - -> However ,Yamaha Vendor park companies didn't receive the official letter from SIPCOT till today.
